Potential Hotel Construction Coming to Colleyville

The City of Colleyville is currently considering an application by a land owner, Icon Lodging a/k/a Colleyville Lodging, LLC, to rezone 1.943 acres located at 5200 State Highway 121 situated between La Hacienda Ranch and JR's Grill and directly adjacent to Colleyville Heritage High School. The request under consideration is to re-zone the property from the existing CC-2 Shopping Center zoning district to a PUDC – Planned Unit Development Commercial Zoning. Further, the application for case # ZC14-024 is requesting variance allowances to the PUDC zoning to specifically allow adjustments to height restrictions regarding their desired construction of a 5-story hotel at this site.

CC-2 Shopping Center zoning in existence for years on this property has allowed for the construction of a hotel not to exceed 2-stories. The property owner is seeking to alter the Colleyville Land Development Code to allow for the construction of a 5-story hotel instead citing that a larger establishment allows for greater price per night. This item has been before the council twice before and has yet to be called for a vote by the council. The first hearing before the council was in December, 2014 and then earlier this month in January. At both meetings, there was a great deal of open forum speaking regarding the application.

In addition, the city has received letters from community members regarding the same application. This application is up for discussion and possible vote at this **Tuesday's meeting, January 20, 2015**. In order to be approved, the vote by the council must be unanimous.

Several homeowners have recently complained to the board that there are homes with trash barrels, recycling barrels and yard waste on the curb more than 24 hours prior to pick up. This not only looks bad, it is in violation of Colleyville regulations. Garbage and the like cannot be placed on the street until 24 hours before pick up.

Apparently many lawn services are leaving bags on the curb. Lawn service performed on Friday afternoon will result in bags on the street through the weekend and until Tuesday. Ask your lawn company to take your yard waste. If they refuse to do so, please either move their mowing schedule to Mondays or Thursdays (to be picked up on Tuesday and Friday) in order to avoid this violation; or instruct them where to leave these bags (not visible to street) so they can be moved to the curb prior to pick up.
