City Council Is In Love With Roundabouts

I am not sure how many of you are aware that the city is planning to install a series of roundabouts in what they see as an answer to traffic problems while at the same time keeping up with the Jones (Southlake) in appearances. While in some cases roundabouts can be a benefit for traffic flow with nice esthetics and in other ways they can be a safety nightmare. One of the roundabouts that the city is planning to install is at the corner of Jackson/Pool and Glade and I think there are some questions that we need to be aware of before we allow this to happen.

- 1. The primary question to ask is for the safety of our children who either walk or ride their bikes to OC Taylor or other locations and who will have to navigate the crosswalk system at the roundabout. Crosswalks at roundabouts are set back at least 5 to 10 feet back on each street. How will a single crossing guard be able to monitor the intersection once a roundabout is installed? There are a lot of cars that travel through that intersection in the mornings and because roundabouts only cause you to slow down and but not to stop you can create a variety of circumstances that could cause safety issues for our kids especially at this intersection. Three of the corners have large walls that can create a blind spot for a crosswalk that is set back and remember there is only one crossing guard. Think of these various scenarios': People who are trying to get to work, sometimes late, to the gym, to OC Taylor, students getting to CHHS or other schools, talking on cell phones and on and on, all cruising through an intersection which now becomes a 4 way nightmare for a crossing guard or guards. None of them present a great vision for our kid's safety that will travel that path. If you have any questions as to the safety issue all you have to do is ask the current crossing guard who the kids call Mr. Smiley. He believes that this will be a major safety issue with the kids and plans to resign if one is installed
- 2. Think of this safety issue, the idea for a roundabout is to keep cars flowing and suddenly a crossing guard stops traffic at one of the crosswalks and the first car in line stops. It is the traffic hour, lots of cars, what happens with the other cars following the stopped car? Will they stop in the middle of their journey through the traffic circle? If they are paying attention yes and if not or if they are rushed?
- 3. The first thing you will hear is that there a roundabout by a school further up Jackson/Pool in Southlake and they have not had any (Continued on page 4)

Oil Leases and Mineral Rights

By now most of you must have seen or heard all the discussion on mineral rights and the cash payouts being paid out to homeowners by oil and gas companies for the rights to drill and pump natural gas. Also, you might have also seen the many signs around our area regarding the BCMRC: Bedford Colleyville Mineral Rights Coalition. As the President of the BMHOA, I was invited to attend the initial meeting of the BCMRC as the representative of the Brook Meadows Homeowners Association along with other HOA representatives and selected members of non-HOA neighborhoods. The purpose of the meeting was to form and organize a coalition of home, church and business owners within a 2000 acre demographic that encompasses all areas north of Harwood to Hall Johnson and between Hwy 26 and Hwy 121. This coalition would represent all of those who sign a Letter of Intent to join the coalition in negotiating with the oil companies for the best deal possible. Here are some bullet points on what is what:

- Power comes in size, the bigger we are and the more organized we are the more power we will have to get the best deal possible.
- This is a total volunteer organization.
- Costs: would be negotiated into the settlement
- Myth: only one oil company has the rights to drill in this area. There
 are two current oil companies, three Land Management groups, and a
 possible third oil company getting into the mix. The more the better
 because they will start to bid against one another.
- Letter of Intents: Non-binding letters of intent can be withdrawn, but a signed lease cannot. So know your facts before you sign. (Letter of Intent is attached)
- The coalition only negotiates the deal for the best price. When the time comes and a signing date is set, each homeowner will have to sign an individual lease. The idea here is again, the bigger the better.
- The coalition will form various committees to help organize the effort and to hire a lawyer to represent the coalition.
- Mineral Rights: There are a lot of questions as to who owns the
 mineral rights to your home and there have been a lot of vague
 answers to that question. There are also some legal aspects that
 can determine what has or can be transferred from owner to
 owner. Everyone must check their own deed to find out. However,
 regardless of what your deed says, do not assume that is the final
 answer. (Continued on page 4)

problems. That is correct there is one there but if you look on two corners it is industrial, one corner is a large lawn area attached to the School and the forth corner is a housing development. Also when you look at the housing development corner the access to that development is further down on Jackson/Pool so school foot traffic from all four corners is limited.

- 4. Another question to ask is how much land will be required to construct a roundabout and the answer is a lot. Based on my conversation with the city, they will take land from all four corners and the island. If you want to see just how much land will be required all you have to do is to go to the end of Hal Johnson by CMS where the city is installing one now.
- 5. Besides the safety issue the disturbing thing about all of this is that the city is pushing this through in a manner that they will not be required to hold any public hearings on it. I wonder why!
- 6. Yes, traffic at the corner of Jackson/Pool and Glade can be a pain at times but will this change be worth taking the risk or should other considerations be taken?

The timetable on all of this is that the appropriation is in front of the City Council now and once passed the plans will be drawn up in 2009 with construction to follow soon after. Don't you think we should have some say in all of this and to have the opportunity to ask the questions?

- A complete title search has to be done and the recommendation was that you should not to worry about doing the search for yourself. The land managers are already doing that. If they have already contacted you then they have most likely found out that you have some portion, if not all, of the mineral rights to your land. They will flash big numbers around, but the coalition should be able to negotiate a much larger number if we remain together.
- The two thousand acre area has been divided into 6 segments and each segment comprises the various associations within that area and will have a team leader. Brook Meadows is in segment 4.
- Each homeowners Association will be responsible for organizing and collecting their letters of intent.
- WE NEED VOLUNTEERS TO HELP IN THIS EFFORT.
- I am attaching a copy of the BCMRC Letter of Intent. Until we get a committee in place I would suggest that you send your signed copies to the Brook Meadows post office box: PO Box 492, Colleyville, TX 76034
- The BCMRC is willing to hold a meeting in each HOA to explain and answer the many questions that we might have, but we will need to organize that effort


